Don't Veer for Deer!



When driving this fall, you should:

- 1. Watch for the rest of the gang. Deer are pack animals, and rarely travel alone. If a deer crosses in front of you, chances are there are more nearby. Slow down and keep an eye out for more deer darting across the road.
- 2. **Timing is everything.** Deer are most active at dusk and dawn: periods when your vision is most compromised. To add to their terrible timing, deer are on the move during mating season (between November and January) when you're more likely to travel after the sun sets. Slow down and stay alert, especially after dark.
- 3. **Wear your seat belt.** It may not prevent a collision, but if the inevitable happens a seat belt can reduce injuries. This is especially true if you lose control and collide with something bigger, and more stationary than a deer.
- 4. **Take a moment to reflect.** First, look for the road signs. The yellow diamonds with the deer on it are placed in high-traffic areas for deer. You may also spot a deer because their eyes will brightly reflect a car's headlights, making them easier to spot.
- 5. **Stay Center.** On a multi-lane road, the center lane is your safest bet for avoiding a deer collision, as long as your local traffic laws permit it. This gives deer plenty of space; and in case your vehicle does startle them, it gives you more time to react if one darts onto the road.
- 6. **Stay the course.** If you see a deer, brake firmly and calmly, and stay in your lane. Swerving could make you lose control of your vehicle and turn a bad situation much worse. Not to mention, deer are unpredictable, and you could swerve directly into their changed path.
- 7. **Honk!** Some experts recommend that one long blast of the horn will scare deer out of the road. Do not rely on hood whistles or other devices designed to scare off deer—studies have shown them to be largely ineffective at minimizing accidents.

Turkey Fryer Safety

NFPA discourages the use of outdoor gasfueled turkey fryers that cook the turkey in hot oil. The use of turkey fryers can lead to devastating burns, other injuries and the destruction of property.



The Dangers of Turkey Fryers

- •Hot oil may splash or spill during the cooking.
- Contact between hot oil and skin could result in serious injury.
- •A hot oil spill can happen with fryers designed for outdoor use using a stand. The fryer could tip over or collapse causing the hot oil to spill. Newer countertop units using a solid base appear to reduce this risk. NFPA does not believe the risks of either type of turkey fryer to be acceptable because of the large amount of hot oil involved and the speed and severity of burns.
- •In deep frying, oil is heated to temperatures of 350° Fahrenheit or more.
- •Cooking oil is combustible. If it is heated above its cooking temperature, its vapors can ignite.

Propane-fired turkey fryers must be used outdoors. **They are very popular for Thanksgiving**. Many parts of the country may have rain or snow at this time of year. If rain or snow hits the hot cooking oil, the oil may splatter or turn to steam, leading to burns.

Turkeys must be completely thawed before placing in the fryer, because a partially thawed turkey will cause the oil to splatter causing serious burns.

The fryers use a lot of oil, about five gallons.

Considering the size and weight of the turkey, extreme caution must be taken when placing and removing the turkey from the fryer to be sure its is not dropped back into the fryer, splattering the oil on the chef.

Oil-less Fryers

NFPA urges those who prefer fried turkey to look for grocery stores, specialty food retailers, and restaurants that sell deep fried turkeys, or consider a new type of "oil-less" turkey fryer."



Acing Your Interview: Five Tips for Safety Professionals

1. Polish your resume.

Whether you are just out of college and looking for your first job or a seasoned professional wanting to take the next step, your resume is a potential employer's first impression of you. As such, make sure that the skills and experience required for a particular position are included in your resume.



2. Do your research.

Before applying or interviewing for any position, it's important to learn as much as you can about the job and the company. While your resume is an employer's first impression of you, this research will give you an initial impression of them. From looking at a company's website, to reading reviews, to speaking with employees, there are numerous ways for candidates to learn about a potential employer.

3. Highlight your accomplishments.

A pitfall that candidates at times fall in to is filling their resumes with skills and responsibilities instead of accomplishments. It's important to let a potential employer know what you have achieved and the impact those achievements have had on the business.

4. Help employers remember you.

After the interview, it's always helpful for the employer to have a reason to remember you. If they want to ask any follow-up questions or schedule a second interview, having your contact information can help speed that process along.

5. Find the right fit.

Accepting a position is a major decision. Along with pre-interview research, use the interview to learn as much as you can about the potential employer, what your role would be and how it fits into the organization. The interview process provides insights into the organizational culture and how you, as a safety professional, fit into that.

Grants are generally valued between \$500 and \$1,000. Applications are accepted through December 1 every year and must be submitted online. Grant recipients will be required to provide receipts of their purchases before grant awards will be disbursed.
