Resolution 2 – OKC Half Marathon. Not ever going to happen—multiple injuries during training.

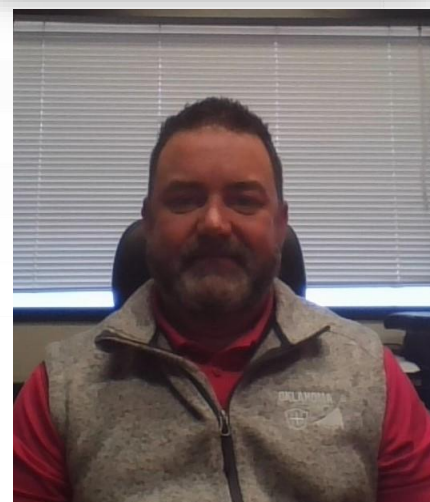

### 2021 SPY Requirements

**Eligibility:** Open to any member of the Oklahoma City Chapter, in good standing, working in the safety, health, or environmental (SHE) field for five years or more.

### Application Packet:

1. Must contain three letters of reference (clients, employer, or colleagues).
2. Accomplishments they have achieved while working in the SHE field during the past five years. (Introduced a new program, reduced Experience Mod by XX%, Best Service Award, wrote a safety program...)
3. ASSP Service – participate in Chapter or Section activities, attended monthly meetings, served as Chapter or Section Officer, served on Regional or National Committees...

### Extra Credit will be given for the following:

- Voluntary Community Service
- Conference Presentation/Publications
- Professional Designations
- Degree in SHE
